In pursuance of the Director of Food, Civil Supplies & Consumer Affairs, Assam, Guwahati's W.T. No.DS.197/2011/39 dated 17/11/2011 allotting 9020.00 Qtls. of Additional APL Rice for the month of Dec'11, Jan'12 and Feb'12. Sub-allocation is hereby made to the following GPSS & FP Shops who will lift the allotted quota of rice from FCI FSD. The last date for deposit of value for the month of Dec/11 is 15/12/11 and lifting is 20/12/11, for Jan/12 the last date for deposit of value is 15/01/12 and lifting is 20/01/12 and for Feb'12 the last date for deposit of value is 15/02/12 and lifting is 20/02/12 positively. The rice will have to be issued to APL families having no BPL, AAY and MMASY beneficiary card. The quantum of rice is fixed as 8.865 kgs. per family against each month.


